The RPP credential is an assurance of quality for employers who want to attract the most professional, skilled and competent planners. RPP's bring added value to their employers and their communities.

The Institute encourages all RPP certified members to proudly use the RPP professional designation alongside their names, in business signatures on business cards, in email signatures and on professional social media sites such as LinkedIn. This further promotes the planning profession and raises the credibility and profile of Registered Professional Planners (RPP's). With the goal of aiming for a consistent approach across Canada, the PTIA's have committed to encouraging RPP members to members to adopt the practice of listing the "RPP" designation immediately following their name, followed by "MCIP", where applicable to denote the national affiliation with CIP.
